

Mid Term Meeting (MTM) travel fund for the Middle European Region

Conditions for the Mid Term Meeting (MTM) travel fund for the Middle European Countries

At the MTM in Brasov in January 2001, there were ideas to found a MTM travel fund for Middle European Countries. Especially because of the fact that not every financial situation of the middle European Ladies' Circle countries are equal. At the Dutch national AGM in May 2002 Utrecht, the Dutch LC members voted in favour of this proposal. At the MTM in Klagenfurt in January 2003, all national boards voted in favour of this proposal.

This MTM travel fund is for Middle European Countries only and contains the following conditions:

- The travel fund and its conditions apply to the following countries:
Romania, Austria, Great Britain & Ireland, Belgium, Germany, The Netherlands
- The fund is only to enable national board members to attend to the Mid Term Meeting
- The fund can only be used to pay for the costs of the MTM
- Each year 1 € (one euro) per member will be donated, up to a maximum of a hundred euros per country
- The year starts at July 1st and ends at June 30th
- Each country (belonging to these MTM countries) can apply for this MTM travel fund in a certain sequence. The sequence of the MTM countries for this fund is:
Romania (MTM 2005), Austria (MTM 2006), Great Britain & Ireland (MTM 2007), Belgium (MTM 2008), Germany (MTM 2009), The Netherlands (MTM 2010)
- Each year before October 31st, the MTM travel fund treasurer sends out the bills per email or regular mail to all MTM national treasurers
- The treasurer of this MTM travel fund will be responsible for the amount that will be received from MTM countries as well as for the amount of money paid to the MTM country.
- When a country that entitled to the yearly grant of this MTM travel fund, they can either apply for the amount, or transfer the donation to another MTM country. This should be done in writing before November 15th previous to the MTM by sending a letter/email to the MTM travel fund treasurer.
- The MTM travel fund treasurer is the treasurer of the country that organizes the MTM.
- The national treasurer of LC The Netherlands will send a reminder to the MTM travel fund treasurer about this MTM travel fund for Middle European Countries, every year in September

This paper was an attachment to an Email send to all presidents of the countries concerned in which the following additional agreements were stated:

- The conditions were adopted on the MTM 2004
- Luxemburg was included in the row, thus being receiver for travel fund for MTM 2011
- If a new country joins Ladies Circle and the Middle European Region, it will be added last in the above stated row.
- The president and the treasurer of the country, which will get the MTM travel fund next, will have to apply for the amounts themselves (always depending on the new number of members)
- If a country does not apply for the amount before 15th of November (before the MTM), the money will remain in the countries for their own disposition.
